Convertible notes held by Swifter Limited, a company owned and controlled by Mr Poh Kay Ping, a director of the Company, with a face value of RMB10 million (\$1,973,530) and accrued interest of RMB 1,961,111 (\$387,031), were redeemed in the December 2017 quarter. \$1,350,756 of the redemption proceeds were used to settle a rights issue underwriting obligation in the December 2017 quarter, and the balance net of withholding tax was paid during the quarter.
